# Significant Event Notice

Dear Members,

We are writing to notify you of a **fee reduction** for all members effective from 30 June 2021, as well as some **changes to the benchmark allocations** and **Standard Risk Measures** within the Balanced investment option which took effect at the end of April 2021.

#### Fee reduction

The total dollar-based Administration Fee charged on all accounts with a balance greater than \$5,000 is being reduced to \$60 per annum from 30 June 2021, from \$93.60 per annum. This fee will continue to be charged monthly to all member's accounts at a rate of \$5 per month. Accounts below \$5,000 are not charged a dollar-based Administration Fee. The Indirect Cost Ratio (ICR), which is an estimate of investment-related costs (including performance-related fees payable to external managers) not otherwise captured in the Investment Fee, is also reducing from the current 0.120% per annum, to 0.112% per annum. This fee will continue to be deducted from the investment returns of the underlying investments and is not deducted directly from your account.
